# ICCM MEMBER REVIEW PANEL

At the beginning of the year the Board of Directors advertised for people interested in joining an independent panel to review the work and workings of the Institute. The aim is to compile a consultation paper and questionnaire to be sent to every member of the Institute and then to make recommendations for change to the Board based on the results.

At its first meeting the panel considered the terms of reference outlined by the Board and developed a work plan. The panel were unanimous in their desire to ensure every Institute member is given the opportunity to contribute to the review from an early stage. To this end the panel decided to advertise its work with this newsletter item outlining the review process and the names and contact details of the people involved.

The first stage of the review is to compile the questionnaire, and any member wishing to contribute should contact one of the panel members with their comments or suggestions on particular questions they think should be included.

At this stage the panel has been divided into three sub groups to do preparatory work on different areas of the review. If you do want to make comments you can contact any panel member about any subject, or alternatively one of those on the relevant sub group. The panel is also hoping that the issues will be discussed at branch meetings (where meetings are taking place) and that any comments and conclusions are conveyed back to the panel either through their representative on the panel (if they have one) or by the branch secretary.

## <u>Sub Group 1</u>

- 1. To review the committee and board structure of the ICCM and consider what improvements could be made to maximise democratic representation and organisational effectiveness.
- 2. To review membership classifications and qualification / CPD requirements and / or the absence thereof.
