

Preparing for an anchor test



A deep counter bore may reduce the anchor engagement with the memorial base.


The manufacturers will need to specify this.

Over the last few months we've been waiting for BSI to complete a review of BS8415 and issue a revised standard. After considerable input from the industry this process

Meanwhile, we want to acknowledge that whilst regulation can sometimes feel like unnecessary red-tape, it is necessary in an industry where poor workmanship and dangerous installations were commonplace in the past. The more willing we are to comply with what serves us all as a whole, ensuring a level-playing field on which to do business, the less resistance we have to such regulations.
