

THURSDAY 15 JUNE 2017 Environment Agency Updated Guidelines for Groundwater Protection in Cemeteries

In March 2017 the Environment Agency published updated Guidelines relating to groundwater protection in cemeteries, placing new obligations on cemetery operators.

Under new guidelines, all cemeteries must undertake an appropriate risk assessment and be managed to reduce their risk and impact on the environment. Any extension to an existing site or new cemetery proposal must comply with the latest requirements.

The aim of the seminar is to inform all burial authorities of the changes to the guidelines and the implications this may have for their cemeteries. The seminar will also cover how to manage potential ground and surface water problems in cemeteries.
