# **REPORT OF THE BOARD OF DIRECTORS**

The Board thanks members for another 12 months of hard work and dedication to serving bereaved people

The Report of the Board of Directors in the AGM 2021 Handbook spoke of how the ICCM and its members managed to adapt to the emerging situation caused by the Covid-19 pandemic. We all started the pandemic with no knowledge of what was to come, and with fears for ourselves, our families and our roles. But in true ICCM style, members and officers rose to the challenges and continued to provide the best possible services for bereaved people.

The pandemic lasted longer than was first anticipated, and continued to disrupt our lives in so many ways through 2021 and into 2022. For the ICCM it meant that physical events such as the Education Seminar and the Learning Convention and Exhibition couldn't be held. Fortunately some branches were able to hold meetings, which meant that members could get together for mutual support and learning. We thank the Branch Secretaries for organizing the meetings, and the members who attended them. But we very much missed the events and the opportunities they provide for networking and sharing experiences, and look forward to resuming them this year.

To keep members up to date and provide opportunities for learning, the ICCM delivered regular e-newsletters, as well as the quarterly Journal. We also continued to hold regular webinars, where a wide variety of subjects was discussed, and which attracted audiences of up to 60 people. These proved very popular, especially the ICCM Question and Answer sessions, where officers discussed some of the questions that they had been asked. It was always interesting to hear different views on some of these tricky subjects, and a good opportunity for Officers to give the ICCM view to assist members.

COTS training resumed in 2021, and our COTS Manager has been incredibly busy trying to catch up with the backlog that accrued during the various lockdowns. Thank you to those

authorities and companies who have waited patiently for us to catch up. We know it is worth the wait to have the reassurance of employing properly trained cemetery operatives.

Demand for CTTS courses remained high through 2021 and into 2022. As the pandemic eased, employers took the opportunity to build resilience in their teams by putting them through this high quality accredited qualification. The Board thanks the ICCM Officers and CTTS examiners for enabling this to happen, and congratulates all those who gained their qualification.

The pandemic also meant that the ICCM training courses continued to be delivered (mostly) online. Feedback from attendees has shown that this form of training is beneficial, as nobody has to travel and can therefore access the training from anywhere there is an internet connection. It also helps to reduce our carbon footprint, as no journeys are necessary, and to keep costs down for our members. Online training will continue to be provided, and courses developed to meet members' needs. A new course on Establishing and Managing Gardens of Remembrance has been a well-received addition to the suite of courses the ICCM provides. Congratulations and thank you to the ICCM Officers for developing and delivering this course.

We continue to enjoy a training relationship with the Society of Local Council Clerks. As a result of delivering courses to help town and parish clerks understand their duties in relation to cemeteries, our Corporate membership has grown significantly over the past five years. We welcome all new Corporate and Professional members who have joined since the previous AGM.

The easing of restrictions meant that the on-site Management of Memorials training courses could resume in 2021, meaning that the full range of ICCM courses could be delivered for the first time since 2019. Thanks to all those who administer and deliver the ICCM training courses.

The pressures of the pandemic meant that many found it difficult to find time to study for their Diploma units. The numbers of students enrolling, however, started to pick up towards the end of 2021. Unfortunately around this time, the accrediting body, Pearson, informed us that they would no longer accept new students onto the HNC Diploma course, and that existing students would have until August 2023 to complete their studies. The ICCM has committed to

finding an alternative accreditation route as a matter of urgency, but in the meantime will continue to offer the Diploma as an ICCM qualification. Our thanks to all the tutors for their work in helping members to achieve their Diploma units, and especially to our education partners, Stratford Business School.

Closer working with other organisations across the funeral sector remains in place following the pandemic. The ICCM enjoys a good relationship with the Gardens of Peace Muslim Cemetery, ensuring that issues affecting the Muslim community are heard and support provided. At the start of the pandemic, the ICCM joined the Association of Private Crematoria and Cemeteries, The Cremation Society of Great Britain, the Federation of Burial and Cremation Authorities, the Funeral Furnishing Manufacturer's Association, the National Association of Funeral Directors and the Society of Allied and Independent Funeral Directors in establishing the Deceased Management Advisory Group. This Group meets regularly to discuss ongoing issues, and is also the group that Government departments liaise with to produce guidance around pandemic issues. The group also supports the All Party Parliamentary Group on Funerals and Bereavement (APPG), which ensures that relevant matters get heard in parliament in a timely manner.

The ICCM is part of the Environmental Stewardship Group, which completed a State of the Sector report in December 2021. A joint Seminar was held in March 2022 to discuss the issues for the sector raised in the report. The ICCM remains committed to environmental improvements within the sector, and will build on earlier initiatives such as the metals recycling scheme to provide members with tools for improving their carbon footprint.

The Board remain committed to the core functions of the ICCM in providing support, training, education and best practice guidance to members to enable them to improve services for bereaved people. We know it has been a tough year again, and that we are all still facing challenges presented by the pandemic. Please continue to look after yourself, as well as your colleagues, so that you can continue to help bereaved people.






### Corporate Membership 2017 – 2022




### Professional Membership 2017 – 2022



### Training Courses 2016/17 – 2021/22




### Cemetery Operatives Training Scheme Candidates 2016/17 – 2021/22






### Diploma Awards 2016/17 – 2021/22


