

Minutes of the AGM 2023

Minutes of the Annual General Meeting held on 18th September 2023 at the Chesford Grange Hotel, Kenilworth, Warwickshire

1. Opening of the meeting

The President opened the meeting and welcomed members.

The President informed members that Sally Avis, formerly of Bournemouth Bereavement Services; Angus Carmichael, formerly of Stoke on Trent City Council; Linda Higham, formerly of Spelthorne Borough Council; Alan Till, former President and Director of the ICCM and Chair of the CBA, and Shaun Peters of Wealden Crematorium had died since the last AGM.

Members stood in a minute's silence to remember those lost members and colleagues.

2. Apologies for absence

Kevin Davies had sent his apologies.

Martin Birch, Chair of the Board of Directors, announced that Tim Morris had resigned his position as a Director on the Board of Directors.

3. To approve the minutes of the Annual General Meeting held online on 26th September 2022

Sofia Allana proposed and Mathew Crawley seconded that the minutes were approved as a true record. Members agreed on a show of hands.

4. To receive and consider the report of the Board of Directors for the year ended 31st March 2023

100% of those entitled to vote raised their hand indicating a unanimous vote in favour of Special Resolution A.


As a check, Members were asked to raise their hand if they were against Special Resolution A. No members raised their hand.

Report of the Board of Directors

Onwards and Upwards

The last year has been a very positive one for the ICCM. In 2022/23 the Board of Directors set strategic objectives to ensure that the organisation is fit for purpose now and into the future. As can be seen from the Strategic Objectives section on page 15, many of the targets have been met or are underway or ongoing. This is a great achievement by the small team of ICCM Officers, who work so hard to support members and develop the organisation.

As can be seen from the graphs on pages 17 to 19, the only way is up! With the exception of the number of Charter members, all other graphs show a marked increase on previous year's figures. Particularly pleasing is the large rise in the number of people achieving the Diploma – well done to all those who achieved this prestigious qualification this year. Education and training remain the lynchpin of the ICCM's service to you, to give you the knowledge, skills and confidence to do your job well for the benefit of bereaved people.

2023/24 once again saw a record number of people attending training courses, and training courses delivered. Feedback received following the training is consistently good, with any constructive criticism being used to refine and develop courses. The Board thank all those who deliver training on behalf of the ICCM, as well of those who assist with the administration and technical delivery of the courses.

Our Cemetery Operatives Training Scheme (COTS) was particularly in demand this year, **with a record number of people taking this important accredited training**. With this training under their belt, cemetery operatives across the UK can undertake their duties safely and with due care, resulting in excellent standards for bereaved people. The Board gives its sincere thanks to the COTS manager for his hard work in delivering so many courses to so many people, and to the Administration Officer for her role in keeping up with the paperwork.

The Crematorium Technicians Training Scheme (CTTS) also remained popular, with an increase on the number of people achieving this qualification increasing from the previous year. The Board gives its thanks to all those who mentor, examine and support those undergoing the CTTS training. One of the great strengths of the ICCM is the camaraderie that is produced through member interactions. Branch meetings, the Education Seminar, the Learning Conference and Exhibition, and other ad hoc events provide great opportunities to come together and forge working relationships and friendships that last a lifetime. This is what we most missed during the Covid pandemic, and it is great that we are now back on track in delivering all these events. The Board thank all those involved in organising them, and would encourage all members to make the most of these opportunities to meet and learn.

You can't have failed to notice that the ICCM Journal has had a major makeover and has a fresh new style. The Journal still contains interesting and informative articles, but it is now more accessible as it can be read in print, on a PC, on a tablet, or on a mobile phone. We've also made sure that it is produced in an environmentally friendly way; the paper is all recycled and recyclable, and vegetable inks are used for the print (which is why it smells so good when you open the printed version!). The Board thanks the Journal Editor and our marketing and PR support partners Flourishh for ensuring that the Journal looks good but retains its important role in providing good quality and informative articles.


The revamp of the Journal is just one initiative that the Board have agreed to improve member services. Flourishh are also working on a new website, which will make it much easier for members to engage with the ICCM. E-newsletters have also had a makeover, and we would encourage all members to sign up to receive communications electronically rather than by print wherever possible; not only does this keep costs down, meaning we can keep membership fees low, but it's also better for the environment.

Working with other organisations in the sector remains important to the ICCM; we have a stronger voice together rather than separately.
